Questions on pay and annual increases: An FAQ for staff



Healthy Families and Workplaces Act (HFWA) updates

The HFWA grants employees access to emergency sick leave under specific circumstances. Denver Health provides 80 hours (for one FTE) of paid sick time for public health emergency (PHE)-related absences. As of **Nov. 11, 2022**, PHE includes health needs related to not just COVID, but also flu, respiratory syncytial virus ("RSV") and similar respiratory illnesses. The expansion beyond COVID doesn't give employees an extra 80 hours for those conditions, it just means they can use their 80 hours for a broader range of conditions. As the public health emergency has continued, regulations and guidance have evolved. With new information, Denver Health is revising how it will administer this benefit moving forward with respect to employees' use of PTO and PHE for qualifying illness. Effective **Oct. 9, 2022**, Denver Health capped PHE hours at 80 total, without an annual carry over or reset. Two additional changes will go into effect as of **Dec. 4, 2022**: PHE will not be separate from PTO, and there will be one application for HFWA. If PTO is not available, employees can go into a negative balance for PHE only up to 80 hours. Employee can apply for HFWA leave via the HR Cherwell portal – select Leave of Absence, then HFWA.
