Most Conflicts Involve

- Time Staff Fast and Family Slow
- Listening/Communication Deep Understanding and communication go a long way
- Systems Issues Not just how people are reacting but why.
- Confusion Healthcare is incredibly complex
- Competing Value Systems Conflicts are often less about right/ wrong, but rather reflect different value systems.







Four Principles

- 1. Respect for Autonomy: What the patient wants, or if they cannot speak for themselves, what they would say if they could. 1956
- 2. Beneficence: Do Good think big picture
- 3. Non-Maleficence: Do No Harm (emotional, physical, cultural, spiritual)
- **4. Justice**: Are we treating this patient like we would treat other patients and are we using resources correctly?







Uniform Determination of Death Act: 1980

An individual who has sustained either:

Irreversible cessation of circulatory and respiratory function, OR

Irreversible cessation of all functions of the brain, including the brain stem

Is Dead







The Dead Donor Rule

- Patients must be declared dead before there is removal of any vital organ for transplantation
- Result of a workgroup at Harvard
- Necessitated by the advent of critical care units > improved survival and/or organ viability







Uniform Anatomical Gift Act

- The **Uniform Anatomical Gift Act** (UAGA or the Act) was passed in the US in 1968 and has since been revised in 1987 and in 2006.
- The Act sets a regulatory framework for the donation of organs, tissues, and other human body parts in the US. The UAGA helps regulate body donations to science, medicine, and education.







Case Study

- 47y M, Home hospice patient with end stage ALS
- Wanted to be extubated in hospital
- Donor Alliance was contacted by California OPO
- Donor Alliance contacted hospital
- Donor Alliance met patient and wife at their home & completed ppw, expectations, process, questions
